Dear Mr. Toland:

On May 9, 2022, the Texas Commission on Environmental Quality (TCEQ) received planning material with your letter dated May 6, 2022 for the proposed distribution system -Pine Rock Estates Section.1. Based on our review of the information submitted, the project generally meets the minimum requirements of Title 30 Texas Administrative Code (TAC) Chapter 290 – Rules and Regulations for Public Water Systems and is approved for construction.

The submittal consisted of 8 sheets of engineering drawings and technical specifications. The approved project consists of:

- 2,350 linear feet (lf) of 6-inch, American Water Works Association (AWWA) Standard C-900, dimension ratio (DR) 18 polyvinyl chloride (PVC) pipe;
- 400 lf of 3-inch, ASTM D2241, DR 26, PVC IPS pipe; and
- Associated valves, fittings, and appurtenances.

This approval is for the construction of the above listed items only. Any wastewater components contained in this design were not considered. The authorization provided in this letter does not relieve a Public Water System from the need to comply with other applicable state and federal regulations.

The White Rock Water Plant 1 public water supply system provides water treatment.

The project is located 4 miles northeast from the intersection of Farm to Market Road 2090 and Farm to Market Road 3083 in Montgomery County, Texas.

An appointed engineer must notify the TCEQ's Region 12 Office in Houston at (713) 767-3500 when construction will start. Please keep in mind that upon completion of the water works project, the engineer or owner will notify the commission's Water Supply Division, in writing, as to its completion and attest to the fact that the completed work is substantially in accordance with the plans and change orders on file with the commission as required in 30 TAC §290.39(h)(3).
