**COMMISSION STAFF’S RECOMMENDATION ON COMPLIANCE**

On January 26, 2023, the Commission’s order filed in Docket No. 51407 required Dos Aguas, LLC (Dos Aguas) to file proof of compliance with certain requirements in both Docket No. 51407 and Docket No. 52441.

On March 15, 2023, the administrative law judge (ALJ) filed Order No. 1, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the sufficiency of the information filed by Dos Aguas by March 28, 2023. Therefore, this pleading is timely filed.

**I. RECOMMENDATION ON COMPLIANCE**

The Commission’s order in Docket No. 51407 required a) Commission Staff to provide the Commission a clean copy of the tariff stamped *Approved* to be retained by Central Records within ten days of the Order, b) Dos Aguas to file proof of compliance with the recording requirements in TWC § 13.257(r) and (s) for the areas affected by this application in Docket No. 51407 no later than 45 days after the date of the order, and c) Dos Aguas to file notice in this docket once billing service begins.

On February 6, 2023, Commission Staff provided Central Records an Approved Stamped Tariff in Docket No. 51407.

On February 17, 2023, Dos Aguas provided proof of recording in county records and a notice of commencement of service in Docket No. 51407 and Docket No. 52441.

## **II. CONCLUSION**

Staff respectfully recommends that Dos Aguas has provided the information required to maintain compliance with the Order in Docket No. 51407. Therefore, Staff recommends that the ALJ close Docket No. 52441.
