COMES NOW North Collin Special Utility District ("North Collin") and files this Unopposed Extension of Time for Response to Administratively Complete Petition and Request for Extension of Time for North Collin's Response to the administratively complete Petition and would show the following:

Order No. 5 issued in this proceeding provided a procedural schedule, including deadlines for the CCN holder and intervenors to file a response to the administratively complete petition was granted.¹
