### ORDER NO. 9 GRANTING EXTENSION AND AMENDING DEADLINES

This Order addresses Commission Staff's December 10, 2021 request for an extension. Commission Staff requests additional time to review the filings in this docket, consider recent developments in the processing of streamlined expedited release dockets, and confer with the parties to address certain issues related to the applications.

The administrative law judge (ALJ) grants the extension. By January 7, 2022 Commission Staff must file recommendation on final disposition. The following procedural schedule applies:
