**JOINT REQUEST FOR EXTENSION OF THE DEADLINE TO RESPOND TO
THE PROPOSED ORDER**

COMES NOW, Meritage Homes of Texas, LLC ("Meritage") and the Staff ("Staff") of the Public Utility Commission of Texas ("Commission") (collectively "the Parties") and jointly file this Request for Extension of Time for Filing of Corrections or Exceptions to the Proposed Order and would show the following:

On January 14, 2022, Commission Staff filed its recommendation on final disposition that included a certificate and a map in which it identified the tract of land in relationship to the CCN holder's certificated service area. On February 25, 2022, the administrative law judge (ALJ) filed the Proposed Order and Memorandum. The ALJ established a deadline of March 11, 2022 for the parties to file corrections or exceptions to the Proposed Order.

Upon further review of the January 14, 2022, map that was filed in this docket, Meritage and Staff concur that mapping discrepancies exist, and that the unforeseen mapping discrepancies impact this docket, as well as Docket No. 52293. In Order No. 1 filed on August 19, 2021, the ALJ severed the original petition into two proceedings: (1) Docket No. 52293, which would address the petitioner's petition for streamlined expedited release from the City of Melissa's CCN No. 11482; and (2) Docket No. 52442, which would address petitioner's petition for streamlined expedited release from the CCN holder's CCN No. 11035.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), parties may request that the time allowed for filing any documents be extended for good cause. Meritage and Staff are working

together to resolve the mapping discrepancies in this docket. While the parties have been diligently working to provide corrections or exceptions to the Proposed Order, both Meritage and Staff believe an extension is needed to allow time to file them. Therefore, Meritage and Staff respectfully request that the deadline be extended for six weeks from the filing of this pleading. Meritage will provide Staff revised mapping items by April 1, 2022, and Staff will complete the review of the mapping items by April 22, 2022.

II. CONCLUSION

WHEREFORE, PREMISES CONSIDERED, Meritage and Staff respectfully request a six-week extension to file corrections or exceptions to the Proposed Order and revised mapping items for the final map and certificate to be included with this docket.
