DEFINITIONS

- Staff 3-2** Please provide an affidavit from Hydrotex, LLC, indicating that all capital improvements have been paid for and installed in the requested area to provide adequate and sufficient water service to the requested area.
- Staff 3-3** Please provide a facilities map that shows the location of the water plant, distribution system lines, and connections within the requested area boundaries.
