ORDER NO. 8
LIFTING ABATEMENT, GRANTING GOOD CAUSE EXCEPTION, CERTIFICATE
NAME REQUEST AND REQUESTING PROPOSED PROCEDURAL SCHEDULE

This Order addresses the April 18, 2022, request by Commission Staff to lift abatement of this docket, recommendation on good cause exception and certificate name, and request to restyle the docket.

I. Good Cause Exception

Commission Staff recommends that the good cause exception and certificate name request be approved and requests that the abatement in this proceeding be lifted. On April 7, 2022, SDLA requested a good cause exception to any requirement for SDLA to provide complete proof of ownership of the SDLA water system. On March 22, 2022, SDLA filed proof of ownership for Randy Chitwood, who has been the licensed operator for the water system since 1984 and has been acting on behalf of Skyline Drive Landowners Association (SDLA) in this docket as well as other filings with the Commission and the Texas Commission on Environmental Quality (TCEQ). In regard to the good cause exception request, Staff recommends that it would not serve the public interest in this docket to require SDLA to provide proof of ownership for the rest of the owners.

The administrative law judge (ALJ) lifts the abatement and grants the good cause exception,

II. Certificate Name and Restyling Docket

SDLA's additionally requests the certificate to be issued in the name of Skyline Drive Landowners Association Water System. Commission Staff recommends that it would serve the public interest for SDLA to be allowed the continued use of this name and requests that the docket be restyled to reflect the requested name.

The administrative law judge grants the request and restyles the docket as reflected in this Order.

III. Provide Certificate


