COMMISSION STAFF'S REQUEST FOR EXTENSION

On August 20, 2021, Skyline Drive Landowners Association Water System (SDLA) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12479 by decertifying a portion of the service area in Johnson County. SDLA filed supplemental information on September 15, 2021 and September 21, 2021. In the latter filing, SDLA clarified its intent that it is only requesting to decertify a portion of its water CCN. The requested service area for decertification consists of approximately 22 acres and zero existing customer connections.

On May 17, 2022, the administrative law judge (ALJ) filed Order No. 9, establishing a deadline of June 20, 2022 for SDLA and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) to file a joint proposed notice of approval with proposed findings of fact, conclusions of law, and ordering paragraphs. Pursuant to 16 Texas Administrative Code (TAC) § 22.4(a), because the Commission was closed for business on June 20, 2022, Staff interpreted the deadline to be the next day that the Commission was open for business or June 21, 2022. Therefore, this pleading is timely filed.

I. FINAL RECOMMENDATION

Under 16 TAC § 22.4(b), parties may request that the time allowed for filing any documents be extended for good cause. The Parties require additional time to draft and confer on a joint proposed notice of approval. Accordingly, Staff respectfully requests that the Parties be given a deadline of June 27, 2022 to file a joint proposed notice of approval.

II. CONCLUSION

Staff respectfully requests the entry of an order extending the deadline to file a joint proposed notice of approval to June 27, 2022.
