**CHAMBERS CREEK RANCH’S MOTION TO ADMIT EVIDENCE**

On August 26, 2021, Oncor Electric Delivery Company LLC (“Oncor”) filed an application to amend its certificate of convenience and necessity for the Old Country Switch 345-kV tap transmission line project in Ellis County.

On March 31, 2022, Oncor, Public Utility Commission of Texas (“Commission”) Staff, and the intervenors in this docket, including Chambers Creek Ranch, LLC (“Chambers Creek Ranch”), filed a unanimous stipulation and settlement agreement (“Stipulation”) supporting approval of the proposed transmission line along Route 152 as an agreed settlement route (the “Settlement Route”).

The Commission considered the Stipulation at the Open Meeting on May 26, 2022, and by ordered dated May 31, 2022, the Commission remanded the docket to the Office of Policy and Docket Management for the parties to file testimony in support of the Stipulation.

On June 7, 2022, Chambers Creek Ranch filed the testimonies of Mr. Barron D. Kidd and Mr. Brian C. Andrews, each of whom testifies in support the Stipulation and provides additional details concerning the merits of Stipulation and of Route 152 relative to the routing criteria the Commission considers in selecting a route for a new transmission line.

Therefore, Chambers Creek Ranch respectfully requests that the testimonies of Mr. Barron D. Kidd and Mr. Brian C. Andrews be admitted into evidence.
