**INTERVENOR LONE STAR TEXAS LAND & CATTLE COMPANY, LLC’S**  
**MOTION TO ADMIT EVIDENCE**

On August 26, 2021, Oncor Electric Delivery Company LLC (“Oncor”) filed their application to amend its certificate of convenience and necessity for the Old Country Switch 345-kV tap transmission line project in Ellis County. On September 16, 2021, Intervenor Lone Star Texas Land & Cattle Company, LLC (“Lone Star”) filed their Motion to Intervene. On September 29, 2021, the Public Utility Commission of Texas (“Commission”) issued Order No. 3 granting Lone Star’s intervention. On March 31, 2022, Oncor, Commission, Lone Star and the other intervenors in this docket filed a unanimous stipulation and settlement agreement (“Stipulation”) supporting the approval of the proposed transmission line along Route 152 as an agreed settlement route. On May 31, 2022, the Commission remanded the docket to the Office of Policy and Docket Management for the parties to file testimony in support of the Stipulation.

On June 7, 2022, Lone Star filed the direct testimony of Ted Paup on Behalf of Lone Star Texas Land & Cattle Company, LLC in support of the Stipulation, interchange item No. 100. Lone Star respectfully requests that this direct testimony be admitted into evidence.
