The Commission should add findings of fact to reflect additional procedural history.

- XX. On May 17, 2022, Oncor filed an intervenor map that shows the routing segments in the application, habitable structures, and features such as existing roads, transmission lines, bodies of water, airports, and heliports.
- XX. In Order No. 10 filed on May 18, 2022, the Commission ALJ admitted the map filed on May 17, 2022 into the evidentiary record.
- XX. On May 31, 2022, the Commission filed an order remanding the proceeding to Docket Management for the parties to file testimony in support of the unanimous agreement so that the Commission could properly evaluate the merits of the parties' agreement.
- XX. On June 4 and June 7, 2022, Anne Weary filed additional testimony.
