ORDER NO. 2
FINDING RESPONSE, APPLICATION, AND NOTICE SUFFICIENT

This Order address the August 26, 2021 application of Oncor Electric Delivery Company LLC to amend its certificate of convenience and necessity (CCN) for a proposed 345-kilovolt transmission line in Ellis County.

On September 9, 2021, Oncor filed its responses to the four standard electric CCN questions posed in Order No. 1

On September 16, 2021, Oncor filed the affidavit of Ife Adetoro, Oncor's authorized representative, attesting that notice of the application was provided on August 26, 2021, by e-mail to the Department of Defense Siting Clearinghouse (DoD), and by mail to: (1) affected landowners; (2) landowners within 300 feet of the centerline of the alternative routes; (3) municipalities within five miles of the alternative routes; (4) county authorities; (5) electric utilities within five miles of the alternative routes; (6) operators of oil and gas pipelines crossed by or within 100 feet of the alternative routes; (7) the Office of Public Utility Counsel; and (8) the DoD. In the affidavit, Ife Adetoro additionally attested that a copy of the application and a copy of the environmental assessment was provided to the Texas Parks and Wildlife Department on August 26, 2021, via overnight mail.


On September 21, 2021, Oncor filed a publisher's affidavit attesting to the publication of notice of the application in the *Ennis News*, a newspaper having general circulation in Ellis County, on August 29, 2021.

On September 24, 2021, Commission Staff filed its recommendations on the sufficiency of Oncor's responses to the four standard electric CCN questions, the application, and notice.

The administrative law judge finds Oncor's response to Order No. 1 sufficient, the application administratively complete, and notice sufficient. Lone Star Texas Land & Cattle Company, LLC and Commission Staff's requests for referral to the State Office of Administrative Hearings for a hearing on the merits will be addressed in a future order.
