MOTION FOR ENTRY OF A MODIFIED PROTECTIVE ORDER

Oncor Electric Delivery Company LLC ("Oncor") files this Motion for Entry of a Modified Protective Order and would respectfully show as follows:

On October 28, 2021, Oncor moved for entry of a modified protective order to protect certain Critical Energy Infrastructure Information ("CEII") and other information responsive to requests for information from intervenor Chambers Creek Ranch, LLC. Oncor's motion for a protective order requested a slight modification to the Commission's standard protective order by revising paragraph 6 of the standard protective order (with a conforming update to Attachment A thereto) to expressly include CEII in the definition of "Highly Sensitive Protected Materials."

Also on October 28, 2021, the Commission issued Order No. 6, which granted Oncor's motion for a protective order but did not adopt the modifications to the standard protective order that Oncor requested. Given the sensitive nature of certain CEII being produced in this docket and the benefit of expressly addressing treatment of such CEII in the Protective Order, Oncor respectfully requests that the Commission adopt Oncor's proposed modification to the protective order, which would expressly include CEII in the definition of Highly Sensitive Protected Materials for the purposes of this proceeding.
