## SOAH ORDER NO. 6 ADMITTING EVIDENCE, REMANDING CASE, AND DISMISSING FROM SOAH DOCKET

On March 31, 2022, Oncor Electric Delivery Company LLC (Oncor) filed an Unopposed Motion to Admit Evidence, Dismiss from SOAH Docket, and Remand to the Commission (Motion). The filing indicated that Oncor, the Staff (Staff) of the Public Utility Commission of Texas (Commission), and other intervenors (collectively, the Parties) participated in mediation, which resulted in the Parties entering into a Unanimous Stipulation and Settlement Agreement (Agreement) resolving all issues in this docket.

The Motion requests that the following documents be admitted into evidence:

- 1. Oncor's application and its attachments, filed August 26, 2021;
- 2. Oncor's Response to Order No. 1, filed September 9, 2021;
- 3. Oncor's affidavit attesting to the provision of notice, filed September 16, 2021;
- 4. Oncor's affidavit attesting to the publication of newspaper notice, filed September 21, 2021;
- 5. The direct testimonies of Oncor witnesses Harsh Naik, Brenda J. Perkins, Oscar E. Rodriguez, Kimberly M. Buckley, and Edward A. Zarecky, filed December 17, 2021;
- 6. The letter agreement between Staff, Oncor, and Texas Parks and Wildlife Department; and

7. The Agreement and attached proposed order.

The Motion also requests that this proceeding be remanded to the Commission to consider the Agreement.

As demonstrated by the Agreement, there are no remaining contested issues, and no hearing is required in this proceeding. Accordingly, the Motion is **GRANTED**. The above-referenced documents are **ADMITTED**, and this case is **REMANDED** to the Commission and **DISMISSED** from the docket of the State Office of Administrative Hearings.
