**JOINT PROPOSED PROCEDURAL SCHEDULE**

On August 26, 2021, Oncor Electric Delivery Company LLC (“Oncor”) filed an application to amend its certificate of convenience and necessity for the Old Country Switch 345-kV tap transmission line. On March 31, 2022, Oncor, Public Utility Commission of Texas (“Commission”) Staff, and the intervenors in this docket filed a unanimous stipulation and settlement agreement (“Stipulation”) supporting Commission approval of the proposed transmission line along Route 152. On May 26, 2022, the Commission considered the Stipulation at the Open Meeting. On May 31, 2022, the Commission remanded the docket to the Office of Policy and Docket Management for the parties to file testimony in support of the Stipulation. On June 6, 2022, the Commission Administrative Law Judge issued Order No. 11, requiring the parties to confer and submit a proposed procedural schedule for further processing of this proceeding no later than June 20, 2022. Accordingly, this proposal is timely filed.

Following remand of this docket, on May 27, 2022, the parties conferred and agreed on a proposed procedural schedule, which is attached hereto. This schedule includes agreed deadlines for all parties to provide supplemental testimony supporting the Stipulation and contemplates, subject to the Commission’s discretion, that the Stipulation be reconsidered at the earliest possible Open Meeting after all such testimony has been filed. All parties either support or do not oppose this proposal.
