Chambers Creek Ranch, LLC ("Chambers Creek Ranch"), pursuant to Public Utility Commission ("PUC") 16 Texas Administrative Code (TAC) §§ 22.101, 22.102, 22.103 and 22.104, hereby files its Motion to Intervene in the above-styled and numbered proceeding and in support thereof shows as follows:

- 1. Chambers Creek Ranch owns property located within the service territory of Oncor Electric Delivery Company LLC ("Oncor").
- 2. Oncor has notified Chambers Creek Ranch that its property may be directly affected by Oncor's proposed transmission line that is the subject of this docket. Thus, Chambers Creek Ranch has standing to intervene under 16 TAC § 22.103(b)(2) and has a justiciable interest in this proceeding because one or more of Oncor's proposed routes if selected as the final route for Oncor's proposed transmission line, directly affect Chambers Creek Ranch's property.
