#### COMMISSION STAFF'S REQUEST FOR AMENDED PROCEDURAL SCHEDULE

On August 24, 2021, East Medina Special Utility District (East Medina SUD) and Creekwood Ranches Water Supply Corporation (Creekwood Ranches WSC) (collectively, the Applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Medina County, Texas. Specifically, East Medina SUD, Certificate of Convenience and Necessity (CCN) No. 10217, seeks approval to acquire facilities and to transfer all of the water service area from Creekwood Ranches WSC under water CCN No. 11897. The requested area includes 161 customer connections and approximately 355 acres, comprised of 355 acres of transferred area from CCN No. 11897. The Applicants filed supplemental information on September 3, 2021.

On March 1, 2022, the administrative law judge (ALJ) filed Order No. 7, establishing a deadline of April 6, 2022 for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation regarding the sufficiency of the closing documents and propose a procedural schedule for further processing of the docket. On April 6, 2022, the ALJ filed Order No. 8, finding the closing documentation sufficient and adopting Staff's proposed procedural schedule, which included a deadline of April 20, 2021 for Staff to provide the final maps, certificates, and tariffs, if applicable, to the Applicants for review and consent. Therefore, this pleading is timely filed.

# I. COMMISSION STAFF'S REQUEST FOR AMENDED PROCEDURAL SCHEDULE

Under 16 Texas Administrative Code (TAC) § 22.4(b), the parties may request that the time allowed for filing any documents be extended for good cause. While reviewing the closing documents submitted by the Applicants, Staff inadvertently made in error in calculating the time period necessary for Staff to prepare the map, certificate, and tariff, if applicable. As such, Staff

respectfully requests that the procedural schedule established in Order No. 8 be amended as proposed below.

#### II. PROPOSED AMENDED PROCEDURAL SCHEDULE

Staff proposes the following amended procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Applicants for review and consent	May 11, 2022
Deadline for Applicants to file signed consent forms with the Commission	May 25, 2022
Deadline for parties to file joint proposed findings of fact and conclusions of law	June 6, 2022

#### III. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the entry of an order amending the procedural schedule as proposed above be issued.
