**JOINT NOTICE OF AGREEMENT REGARDING COMPENSATION**

Neimann Farm Partners, LP (hereinafter "Petitioner") and Polonia Water Supply Corporation ("Polonia") file this Joint Notice of Agreement Regarding Compensation in the above-styled matter and would show as follows:


On December 13, 2021, Petitioner filed a Notice of Agreement Regarding Compensation in this docket, stating that Petitioner and Polonia have entered into a settlement agreement providing that no compensation is owed to Polonia as a result of the streamlined expedited release of the Property at issue in this docket from Polonia's Certificate of Convenience and Necessity ("CCN") No. 10420. On January 11, 2022, the administrative law judge issued Order No. 5 in this docket, which orders Petitioner and Polonia to file a joint pleading stating the amount of compensation. This Joint Notice of Agreement Regarding Compensation is filed in accordance with Order No. 5.

Pursuant to 16 Tex. Admin. Code § 24.245(i)(1), Petitioner and Polonia negotiated and entered into a settlement agreement that provided that no compensation is owed to Polonia as a result of the streamlined expedited release of the Property at issue in this docket from Polonia's CCN No. 10420 as requested by Petitioner.

Petitioner and Polonia respectfully request that the PUC issue a Notice of Approval approving the resolution of the compensation issue by agreement of Petitioner and Polonia and closing this docket.


