COMMISSION STAFF'S REQUEST FOR EXTENSION

I. INTRODUCTION

On September 9, 2021, William Brent Davis (Mr. Davis) filed a motion to revoke the Certificate of Convenience and Necessity (CCN) of Drew T. Spencer d/b/a Cypresswood Estates (Cypresswood). Mr. Davis seeks to have the CCN No. 12498 revoked under 16 Texas Administrative Code (TAC) § 24.245(d)(2).

On March 27, 2024, the administrative law judge (ALJ) filed Order No. 15, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the administrative completeness of the petition, along with a proposed procedural schedule, if appropriate, by May 28, 2024. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the mapping information filed on April 25, 2024. Therefore, Staff respectfully requests an extension of time until June 13, 2024, to file a supplemental recommendation regarding the administrative completeness of the petition, along with a proposed procedural schedule, if appropriate.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to June 13, 2024, to file a supplemental recommendation regarding the administrative completeness of the petition, along with a proposed procedural schedule, if appropriate.
