**JOINT STATEMENT ON FINAL MAPPING, CERTIFICATES, AND TARIFFS**

**I. INTRODUCTION**

On September 9, 2021, William Brent Davis (Mr. Davis) filed a motion to revoke the Certificate of Convenience and Necessity (CCN) of Drew T. Spencer d/b/a Cypresswood Estates (Cypresswood). Mr. Davis seeks to have the CCN No. 12498 revoked under 16 Texas Administrative Code (TAC) § 24.245(d)(2).

On September 11, 2024, the administrative law judge filed Order No. 20, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable) to the applicant for review and consent by October 25, 2024 and Cypresswood to file signed consent forms with the Commission by November 8, 2024. Therefore, this pleading is timely filed.

**II. JOINT STATEMENT**

Staff and Cypresswood have conferred. Since this proceeding is a CCN cancellation, there are no final maps, certificates, or tariffs to be provided to the applicant by Staff. Accordingly, Cypresswood will not need to file signed consent forms with the Commission. Staff will file its final recommendation on the application by November 15, 2024, in accordance with the procedural schedule established in Order No. 20.
