- a) If yes, please provide supporting documentation.
 - b) If no, please provide an explanation why an RFP was not issued.
- Staff 5-3** Referring to SPS's response to Sierra Club 1-17 (a) and (b), please provide supporting documentation of SPS's Request for Information and the responses submitted to evaluate the availability and cost of alternative resource options.
- Staff 5-4** Please explain and provide documentation, if SPS has adequately considered alternative sources of natural gas.
- Staff 5-5** Please explain and provide documentation, if SPS considered purchasing capacity from a competitive generator.
