- Staff 1-1** Please provide the detailed construction and design plans for the plant. Please provide these requested plans for the plant both as (a) currently designed and (b) with the proposed changes to the plant, including location.
- Staff 1-2** Please provide details for the natural gas pipeline and routes under consideration.
- Staff 1-3** Please provide the Environmental Assessment (EA) and route analysis for the construction of new pipeline as referred on page 6 of the application. Please provide this in native file format. Please include the correspondence with state, federal and other agencies.
- Staff 1-4** Please provide the detailed cost analysis of the plant and comparative cost analysis for the routes under consideration for the gas pipeline. Please provide this in native file format.
- Staff 1-5** Please explain whether SPS or some other company will own the pipeline.
