

**CONFIDENTIALITY STATEMENT UNDER  
SECTION 4 OF THE PROTECTIVE ORDER**

The undersigned attorney for Southwestern Public Service Company (“SPS” or the “Company”) submits this statement under Section 4 of the protective order entered in this case and has reviewed the information provided in SPS’s Proof of Notice filing made on November 4, 2021 sufficiently to state in good faith that the information is exempt from disclosure under the Texas Public Information Act (“PIA”) and merits the Protected Materials designation.

The Proof of Notice filing made on November 4, 2021 contained the personally identifiable information and addresses of third-party individuals that are not party to this proceeding. As is in other proceedings before the Public Utility Commission of Texas, personally identifiable information, including addresses, of individuals not participating in the proceeding should not publicly released. SPS, therefore, has a commercial responsibility to protect such information from public disclosure to the extent practicable. Public release of the information would cause substantial competitive harm to SPS and third parties that are not parties to this proceeding. The information is therefore exempt from disclosure under Section 552.110(c) of the PIA.


