**COMMISSION STAFF’S COMMENTS ON SUFFICIENCY OF NOTICE**

On August 27, 2021, Southwestern Public Service Company (SPS) filed an application to amend its Certificate of Convenience and Necessity (CCN) to convert the three generation units at Harrington Generating Station from coal generation to natural gas generation.

On November 5, 2021, the administrative law judge filed Order No. 6 directing Commission Staff (Staff) to file comments regarding SPS's November 4, 2021 proof of notice by November 25, 2021. Therefore, this pleading is timely filed.

**I. SUFFICIENCY OF NOTICE**

Staff has reviewed SPS’s proof of notice documents and recommends that SPS’s published and direct notices include all required information and were provided in compliance with the notice requirements of 16 Texas Administrative Code § 22.52(a). Therefore, Staff recommends that SPS’s notice be found reasonable and sufficient.

**II. CONCLUSION**

For the reasons stated above, Staff recommends that SPS’s notice be found sufficient. Staff respectfully requests that an order be entered consistent with these recommendations.
