

**ARLEDGE RIDGE WATER SUPPLY CORPORATION'S RESPONSE TO
COMMISSION STAFF'S FOURTH REQUEST FOR INFORMATION
QUESTION NOS. STAFF 4-1 THROUGH 4-4**

STAFF 4-1: In Arledge Ridge WSC's response to Staff's RFI 3-2, Arledge Ridge WSC provided a specific example of a "Standard Service" applicant in which a pipeline and/or service extension was not required for the applicant that resides at 655 CR 4715. Please provide any specific costs with a detailed description for parts, labor, and equipment necessary to provide water service to that address.

RESPONSE: Please find attached as "Exhibit A" an invoice reflecting the specific costs for parts necessary to provide water service to the applicant that resides at 655 CR 4715. The additional costs that the applicant owed are:

- \$100 for membership,
- \$600 for installation, and
- \$2,300 capital improvement fee.

STAFF 4-2: If there are no construction labor and materials, inspection, administration, legal, and engineering fees associated with an applicant, but the existing pipeline that will provide service to the applicant is at capacity, is that still considered “Non-Standard” Service?

RESPONSE: Yes. A non-standard service application is used when any service request will require changes to the water system to provide service. An existing line at capacity would be an instance of this.

STAFF 4-3: Please provide a detailed list of any pipeline within Arledge Ridge WSC's service area that has reached its capacity limit.

RESPONSE: The Texas Commission on Environmental Quality (TCEQ) promulgates rules regarding line capacity, including information regarding the maximum number of connections, based on waterline sizes. A 2-inch waterline is recommended to have no more than ten meters on it. Currently, the District's 2-inch waterline located on CR 4650 and CR 4640 has 12 meters on it. The District's engineer would not recommend additional meters be placed on that line without system improvements first being made.

In regard to 1.5-inch waterlines, TCEQ does not recommend them, and considers 2-inch waterlines as a required minimum size. The District has several 1.5-inch waterlines on the system that the District's engineer would not recommend that the District utilize unless system improvements were made.
