**BRAD WHITE’S MOTION TO DISMISS THE COMPLAINT**

COMES NOW Brad White and files a Motion to Dismiss his complaint against Arledge Ridge Water Supply Corporation (“Arledge”).

**I. Background**

On September 1, 2021, Brad White filed a complaint against Arledge for failure to provide water service. On February 9, 2022, the Commission referred the case to the State Office of Administrative Hearings (“SOAH”). On February 11, 2022, the Commission issued a Preliminary Order listing issues to be addressed at hearing.

On April 19, 2022, Brad White and his attorney, Carey Olney, and Alan McDonald (Board President for Arledge) and Arledge’s attorney, Grayson McDaniel, participated in mediation through SOAH to resolve the issues in this case. The Parties successfully mediated an agreement in which Mr. White will receive water service from Arledge. The Parties memorialized the agreement in writing on April 22, 2022, resolving all issues in this matter.

**II. Conclusion**

Because the agreement signed by the Parties resolves the issues underlying the complaint, Brad White moves that the complaint be dismissed without prejudice.
