**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On September 1, 2021, Brad White filed a formal complaint against Arledge Ridge Water Supply Corporation (Arledge) related to Arledge's refusal to provide Mr. White water service on his premises.<sup>1</sup> The complaint was filed under 16 Texas Administrative Code (TAC) § 22.242. Arledge filed a response on October 4, 2021.<sup>2</sup>

On October 13, 2021, the administrative law judge (ALJ) filed Order No. 2, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental statement of position no later than November 8, 2021. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On November 3, 2021, Staff filed its first Requests for Information requesting Arledge provide further information related to the complaint. Staff respectfully requests an extension of time to conduct additional discovery and a review of responses to the same. Staff respectfully requests an extension of time until December 6, 2021 for Staff to file a supplemental statement of position.

**II. CONCLUSION**

Staff respectfully requests that its deadline to file a supplemental statement of position be extended until December 6, 2021.
