COMMISSION STAFF’S MOTION FOR AN AMENDED PROCEDURAL SCHEDULE

On September 1, 2021, Karen Reeves dba R & N Enterprises (R & N) and Monarch Utilities I, L.P. (Monarch) (collectively, the Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Cooke County. Specifically, Monarch Utilities, certificate of convenience and necessity (CCN) No. 12983, seeks approval to acquire facilities and to transfer all of the water service area from R&N under water certificate of convenience and necessity (CCN) No. 11614. Monarch filed supplemental information on September 28, 2021, November 15, 2021, February 11, 2022, March 9, 2022, April 20 and 29, 2022.

On June 9, 2022, the administrative law judge filed Order No. 9, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable), to the applicants for review and consent by July 7, 2022. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION AND MOTION FOR AN AMENDED
PROCEDURAL SCHEDULE**

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to work with the parties to prepare the final maps, certificates, and tariffs.

Accordingly, Staff proposes the following procedural schedule:

| Deadline for Applicants to file signed consent forms with the Commission. | July 28, 2022 |
| Deadline for parties to jointly file a proposed notice of Approval, including proposed findings of fact, conclusions of law, and ordering paragraphs. | August 11, 2022 |

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the deadline for Staff to provide final maps, certificates, and tariffs (if applicable), to the applicants to review and consent until July 14, 2022 and that the proposed amended procedural schedule be adopted.
