JOINT MOTION TO ADMIT SUPPLEMENTAL EVIDENCE

I. Background

On May 26, 2023, Staff (Staff) of the Public Utility Commission (Commission) and Applicants Texas Water Systems, Inc. (Texas Water), and Undine Texas LLC (Undine) (collectively, the Parties) filed their Joint Motion to Admit Evidence pursuant to Order No. 23. On May 30, 2023, the Administrative Law Judge (ALJ) filed Order No. 24, requiring the Parties to file a supplemental motion to admit evidence regarding Staff's supplemental recommendations. On July 24, 2023, the ALJ filed Order No. 25, requiring the Parties to file a joint motion to the supplemental evidence responsive to Order No. 24 on or before August 7, 2023.


