COMMISSION STAFF’S REQUEST FOR EXTENSION

On September 2, 2021, Texas Water Systems, Inc. (TWS) and Undine Development, LLC (Undine) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Gregg, Henderson, Smith, and Upshur Counties. Applicants filed supplemental information on September 14, September 27, November 4, November 5, December 7, and December 23, 2021; and January 24 and April 29, 2022.

On September 12, 2023, the ALJ filed Order No. 28, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of the closing documentation and customer deposit information within 15 days following the filing of applicant’s proof that the transaction has been consummated. Applicants filed notice of completed transaction on October 11, 2023. Fifteen days after October 11, 2023, is October 26, 2023.

I. REQUEST FOR AN EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff conferred with Undine about its closing documents, and Undine requested an additional few days to submit more information regarding their closing documents. Staff accordingly requests an extension of Staff’s deadline to file a recommendation on Undine’s closing documents to November 2, 2023.

II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff’s deadline to file a recommendation on Undine’s closing documents to November 2, 2023.
