ORDER NO. 9 GRANTING EXTENSION AND REVISING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's June 13, 2022 request to extend the time to file a request for hearing or file a final recommendation on approval of the sale and CCN amendment. Commission Staff states more time is needed to review the application and file a recommendation. Commission Staff represents that Undine Development, LLC is not opposed.

Under 16 Texas Administrative Code (TAC) § 24.239(a), the 120-day approval period begins the last day the applicants' mailed notice as stated in the proof of notice or, the last date of publication of notice as stated in the affidavit of publication. Additionally, under 16 TAC § 24.239(i), if the Commission does not require a public hearing, the sale, transfer, merger, consolidation, acquisition, lease, or rental may be completed as proposed at the end of the 120-day period described in subsection (a) of this section.

In light of the 120-day deadline, which is June 27, 2022, the ALJ grants Commission Staff's request, with modification and revises the remainder of the procedural schedule as follows:

¹ Under 16 TAC § 24.239(a) and (i), the deadline for Commission action is 120 days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after February 26, 2022, is Sunday, June 26, 2022; therefore, the deadline moves to the next day the Commission is open for business, June 27, 2022.
