### **STATUS UPDATE**

On September 2, 2021, Texas Water Systems, Inc. (TWS) and Undine Development, LLC (Undine) (jointly, Applicants) filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate of convenience and necessity (CCN) rights in Gregg, Henderson, Smith, and Upshur Counties.

On August 2, 2022, the administrative law judge (ALJ) filed Order No. 12 requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) and Applicants (collectively, Parties) to file status reports (or a joint report if appropriate) by August 12, 2022. Therefore, this pleading is timely filed.

## I. STATUS UPDATE

Staff believes Parties have reached an agreement in principle in this docket, and Staff continues to work with Applicants to implement said settlement. Staff expects to file a recommendation on further processing of the docket soon. In the interest of maintaining a procedural schedule in this docket, Staff proposes filing its recommendation, another status report, or requesting a hearing in this docket by August 26, 2022.

## II. CONCLUSION

For the reasons detailed above, Staff respectfully requests the entry of an order consistent with this recommendation.
