## COMMISSION STAFF'S REQUEST FOR EXTENSION

### I. INTRODUCTION

On September 2, 2021, Texas Water Systems, Inc. (TWS) and Undine Development, LLC filed an application for approval of the sale, transfer, or merger (STM) of facilities and certificate of convenience and necessity (CCN) rights in Gregg, Henderson, Smith, and Upshur Counties. On August 26, 2022, the application was amended to replace Undine Development, LLC with Undine Texas, LLC (Undine Texas) as the applicant. Supplemental information was filed on August 29 and 31, 2022.

On December 28, 2022, the administrative law judge (ALJ) filed Order No. 16 requiring parties to clarify whether there are any violations, resolved or unresolved, associated with Undine Texas, LLC in the Commission or the Texas Commission on Environmental Quality's (TCEQ) databases by January 6, 2023. Therefore, this pleading is timely filed.

## II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the application before submitting the clarifications required by the ALJ. Accordingly, Staff respectfully requests that the deadline for Staff to file clarifications be extended until January 18, 2023. Staff has conferred with counsel for Undine and is authorized to represent they support the proposed extension. Staff all conferred with a representative from TWS and is authorized to represent they are unopposed to the proposed extension.

### III. CONCLUSION

For the reasons stated above, Staff respectfully requests that its deadline to file clarifications be extended until January 18, 2023.
