ORDER NO. 5 FINDING PETITION ADMINISTRATIVELY COMPLETE AND NOTICE SUFFICIENT, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the September 3, 2021 petition of Belknap, FP, Ltd. to amend Marilee Special Utility District's water certificate of convenience and necessity (CCN) in Collin County by streamlined expedited release. Belknap filed supplemental information on September 8, 2021, and an amended petition on November 3, 2021.

I. Finding Amended Petition Administratively Complete and Notice Sufficient

On December 3, 2021, Commission Staff filed its supplemental recommendation on sufficiency of the petition and notice. The administrative law judge (ALJ) finds the amended petition administratively complete and notice sufficient.

II. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
