DEFINITIONS

- Staff 1-1** Identify each time period in the last five years, if any, during which the Tract received water or sewer service and identify the retail public utility that provided the service.
- Staff 1-2** If known, identify the number of water connections that will be needed to serve the Tract and the projected timeline for the installation of these connections.
- Staff 1-3** If known, identify the number of sewer connections that will be needed to serve the Tract and the projected timeline for the installation of these connections.
