TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, VPTM Cross Creek LB, LLC ("Petitioner") and submits this Response to the Public Utility Commission Staffs ("Commission Staff") First Request for Information pursuant to Tex. R. Civ. P. 190 through 198 and 16 Tex. Admin. Code § 22.144 ("TAC"). Pursuant to 16 TAC § 22.144(c)(2)(F), these responses may be treated as if they were filed under oath.

- **Staff 1-1:** Identify each time period in the last five years, if any, during which the Tract received water or sewer service and identify the retail public utility that provided the service.
- **Response:** The tract for which Petitioner is seeking streamlined expedited release has not received water or sewer service from any retail public utility in the past five (5) years.
- **Staff 1-2:** If known, identify the number of water connections that will be needed to serve the Tract and the projected timeline for the installation of these connections.

- **Staff 1-3:** If known, identify the number of sewer connections that will be needed to serve the Tract and the projected timeline for the installation of these connections.
- **Response:** The number of sewer connections that will be needed to serve the Tract and the projected timeline for the installation of these connections is unknown at this time.
