**RESPONSE:** The District maintains an 8” waterline that runs along the northern boundary of the Property and extends from the northeastern corner of the Property down to the eastern boundary of the Property. The 8” waterline was put into service in 2004. The District also maintains a 4” waterline that runs down the entire western boundary of the Property. The 4” waterline was put into service in 1990.

**RESPONSE:** The area where the Tract is located is served by Pump Station 2 and has a combined well capacity of 560 gallon per minute, ground storage of 900,000 gallons, two 8,000 gallon pressure tanks, and one 800 gallon per minute booster pump with an unused capacity of 22%. The wells serving the area where the Tract is located were drilled in 1984 and 2016; the pump station ground storage tanks serving the area where the Tract is located were constructed in 1971 and 1988.

The 4-inch waterline is 1,300 linear feet in length, runs parallel with County Road No. 90, and is approximately 100 linear feet from the outer boundary of the Tract.

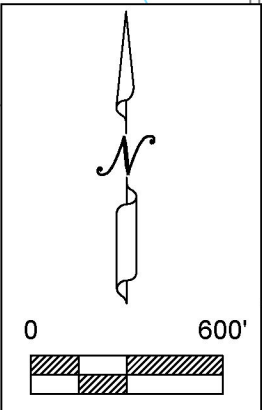
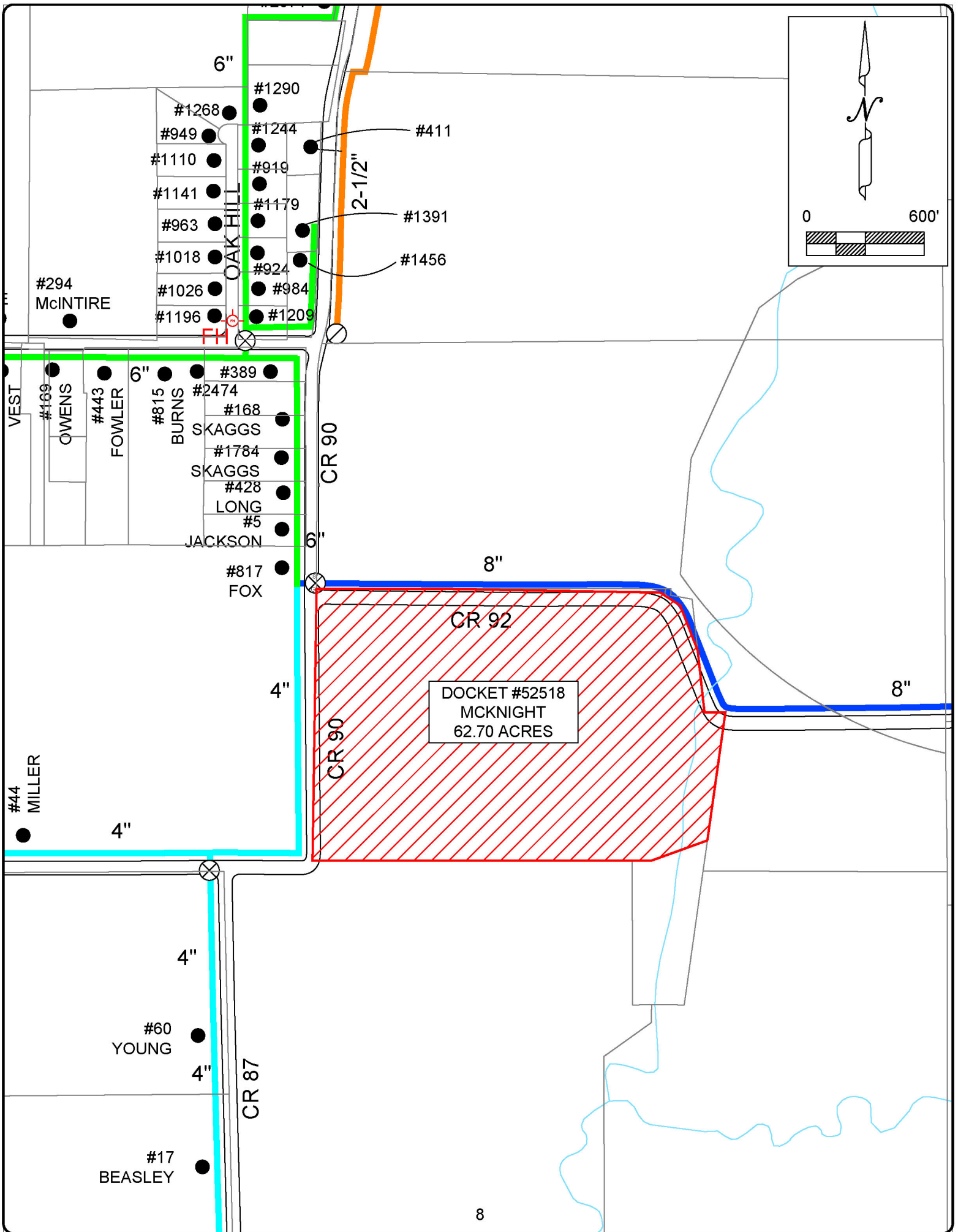
