Approval of a Service Area Agreement Under Texas Water Code §13.248 and to

Amend Certificates of Convenience and Necessity in Smith County

To the Public Utility Commission of Texas:

On behalf of the City of Lindale ("Lindale") please accept this application under Texas Water Code §13.248 and 16 Tex. Admin. Code §24.253 for approval of a service area agreement and to transfer a portion of CCN No.10758 in Smith County, Texas, from Lindale Rural Water Supply Corporation ("LRW") to the City of Lindale, CCN No. Lindale and LRW have both agreed to the transfer. A copy of the agreement is attached as Exhibit A.

The decision to enter into an agreement was presented to and approved by LRW's Board of Directors. The agenda and minutes from LRW's May 28, 2021, Board meeting during which the decision to enter into an agreement was discussed, along with an affidavit attesting to the date of the meeting are attached as Exhibit B. The decision to enter into an agreement was presented to and approved by Lindale's City Council. The agenda and minutes from Lindale's June 1, 2021, Council meeting during which the decision to enter into an agreement was discussed, along with an affidavit attesting to the date of the meeting are attached as Exhibit C

The amount of territory being transferred is approximately 28.72 acres from LRW to Lindale, and there are no existing customers residing on the tract. Small and large-scale maps of the area to be transferred are attached as Exhibit D. The digital data supporting the maps will be uploaded along with this document.

Please let me know if you need any additional information to allow the Commission to incorporate this agreement into the respective CCNs of Lindale and LRW.

Exhibit A

TWC §13.248 Agreement between Lindale and LRW

SERVICE AREA AGREEMENT

This Service Area Agreement (the "Agreement") is by and between the City of Lindale, Texas, (the "City") and Lindale Rural Water Supply Corporation ("LRW") (all the above are also sometimes referred to herein collectively as the "Parties" or individually as a "Party").

RECITALS

WHEREAS the City of Lindale is a municipal corporation in Smith County, Texas, owning a retail public water utility operating under water CCN No. 12795 in Smith County; and

WHEREAS, Lindale Rural Water Supply Corporation is a water supply corporation operating under Chapter 67 of the Texas Water Code, owning a retail public water utility operating under water CCN No. 10758 in Smith County; and

WHEREAS, the owners of a tract of land located inside LRW's CCN, but immediately adjacent to the City's CCN and inside the City's corporate boundaries, (shown as the "Proposed Transfer Area" on Exhibit A) have requested retail water utility service from the City; and

WHEREAS, LRW consents, pursuant to the terms of this Agreement, to allowing the City to provide retail water utility service to the Proposed Transfer Area; and,

WHEREAS, pursuant to Texas Water Code §13.248, contracts between retail public utilities designating areas to be served, when approved by the Public Utility Commission of Texas ("PUC")after public notice and hearing, are valid and enforceable and are incorporated into the appropriate CCNs; and,

WHEREAS, the City and LRW mutually desire to enter into this Agreement setting forth the terms and conditions pursuant to which they will designate areas to be served and to request the PUC to incorporate such designations into the CCNs held by the City and LRW;

NOW, THEREFORE, in consideration of the promises, mutual agreements, and covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City and LRW hereby contract and agree as follows:

ARTICLE I TERMS

- 1.1 Term. This Agreement shall remain valid and enforceable until superseded by subsequent written agreement.
- 1.2 <u>Property Subject to the Agreement.</u> The property subject to this Agreement is the property identified as "Proposed Transfer Area" as shown on Exhibit A.

- 1.3 <u>Transfer of Water Utility Service Area</u>. LRW consents and agrees to the transfer of CCN service territory that includes the Proposed Transfer Area to the City provided the following conditions are satisfied:
 - A. Within 30 days of the execution of this Agreement, the City shall prepare, file, and diligently prosecute, at the City's sole expense, an application pursuant to Texas Water Code §13.248 ("Application") with the PUC to have the Proposed Transfer Area transferred from CCN No. 10758 to CCN No. 12795. LRW shall support the Application and will not object or otherwise attempt to defeat the City's Application to include the Proposed Transfer Area in the City's water CCN.
 - B. Within 10 days after the issuance of a final order issued by the PUC incorporating the Proposed Transfer Area into the City's CCN No. 12795, the City shall pay the sum of \$124,723.00 to LRW as compensation for LRW transferring its CCN for the area to the City.
 - C. If the PUC denies the 13.248 Application for any reason, the City and LRW shall work in good faith to implement a reasonable alternative administrative approach providing the City with the necessary authority to serve the Proposed Transfer Area, including a petition for expedited release under Texas Water Code § 13.2541. In the event that an alternative administrative approach is used, the City shall not be obligated to pay more than \$124,723.00 to LRW for the right to provide service.
- 1.4 <u>Retail Service</u>. LRW hereby consents to the City providing retail water service to the Proposed Transfer Area during the pendency of the 13.248 Application.

ARTICLE II MISCELLANEOUS

- 2.1 No agreements other than this Agreement now exist between the City and LRW concerning the subject matter of this Agreement.
- 2.3 This Agreement shall be binding on the City and LRW and shall be binding on and inure to the benefit of the successors and assigns of the respective Parties to this Agreement.
- 2.4 This Agreement is the entire agreement between the Parties hereto with respect to the subject matter hereof. No modifications of this Agreement shall be of any force or effect, whatsoever, except as by subsequent modification in writing signed by the Parties.
- 2.5 The provisions of this Agreement shall be governed by and construed and entered in accordance with the substantive laws of the State of Texas. Any action at law or in equity brought to enforce any provision of this Agreement shall be brought in a court of competent jurisdiction with venue in Smith County, Texas.
- 2.6 The individuals executing this Agreement on behalf of the respective parties below represent that all necessary and appropriate action has been taken to authorize the individual who is

executing this Agreement to do so for and on behalf of the party for which his or her signature appears, that there are no other parties or entities required to execute this Agreement in order for the same to be an authorized and binding agreement on the party for whom the individual is signing, and that each individual affixing his or her signature is authorized to do so, and such authorization is valid and effective on the date hereof. If the authority of the individual executing this Agreement is subsequently challenged, the party for which the individual was acting shall take all steps necessary to ratify the authority of the individual.

- 2.7 This Agreement may be executed in multiple originals, either copy of which shall be considered an original.
 - 2.8 This Agreement shall be effective on the date of execution below.
- 2.9 No Party will be penalized for alleged authorship of a particular provision on judicial construction of this Agreement.
- 2.10 No Party to this Agreement shall initiate any litigation or arbitration challenging the validity or enforceability of any provision of this Agreement once it has been signed. The Parties reserve only their right to enforce the terms of this Agreement to the extent they are not fully performed by any other Party.


