# ORDER NO. 19 FINDING PETITION ADMINISTRATIVELY COMPLETE AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the petition, filed on September 8, 2021, of E Real Estate, LLC to amend Marilee Special Utility District's certificate of convenience and necessity (CCN) number 10150 in Collin County by streamlined expedited release. On October 8 and 22, November 4, and December 13, 2021; February 18, April 4, June 15, and December 19, 2022; and March 20 and May 22, 2023, the petitioner amended or supplemented the petition.

### I. Finding Application Administratively Complete

On July 5, 2023, Commission Staff recommended that the petition, as amended and supplemented, be found administratively complete. The administrative law judge (ALJ) finds the petition administratively complete. The finding of administrative completeness does not address the merits of the petition.

### II. Establishing Procedural Schedule

Under Texas Water Code (TWC) § 13.2541, the granting of streamlined expedited release initiates an appraisal process to determine the amount of monetary compensation that may be owed by the landowner to the certificate holder for the tract of land that was released. Therefore, an order granting approval for streamlined expedited release is interim in nature and, in the event the requested release is approved, the docket will continue for the purpose of determining the issue of compensation.
