**ORDER REMANDING TO DOCKET MANAGEMENT**

This Order addresses the petition of Central Frisco, Ltd. for streamlined expedited release of a tract of land in Collin County from the service area under Marilee Special Utility District's certificate of convenience and necessity number 10150. The Commission remands this proceeding to Docket Management to give the petitioner the opportunity to amend the petition.

The Commission has previously remanded petitions for streamlined expedited release proceedings in which the petitioner failed to demonstrate that water meters were not located on the tract of land to be released.<sup>1</sup> In this docket, Marilee provided a map that shows two inactive meters are located within the tract of land at issue in this proceeding.<sup>2</sup>

Therefore, the Commission remands the proceeding to Docket Management for the petitioner to have the opportunity to amend the petition and address the two inactive meters on the tract of land at issue.

Docket Management should issue a procedural schedule to set deadlines for the petitioner to amend the petition and for Commission Staff to file a recommendation on final disposition regarding the amended petition. Docket Management should then file a revised proposed order for the Commission's consideration at a later open meeting.




