ORDER NO. 3 GRANTING EXTENSION

This Order addresses Commission Staff's November 22, 2021 request for extension. Commission Staff requests the extension to allow additional time for Brocoskey & Shonnah Maxie (the Maxies) to file supplemental information. In Order No. 2 filed on October 12, 2021, the administrative law judge (ALJ) ordered the Maxies to cure the deficiencies in their appeal by October 26, 2021. The Maxies failed to do so. On November 22, 2021, Commission Staff, after conferring with the Maxies, requested an extension of the deadline for the Maxies to file supplemental information to cure their application deficiencies until December 6, 2021 and an extension for Commission Staff to file a supplemental recommendation on administrative completeness to December 20, 2021. Also on November 22, 2021, Consolidated WSC objected to the requested extension, pointing out that the Maxies did not themselves seek an extension prior to the expiration of their deadline and that Commission Staff failed to show good cause for the extension.

Texas Water Code § 13.043(g) and 16 Texas Administrative Code § 24.101(g) allows an applicant for service from an affected county or a water supply or sewer service corporation to appeal amounts to be paid to obtain service other than the regular membership or tap fees and the appeal must be *initiated* within 90 days after the date written notice is provided to the applicant relating to the applicant's initial request for that service. The Maxies filed their appeal on September 10, 2021, which is based on a written estimate of charges received August 24, 2021. While the Maxies did not cure the deficiencies in their appeal by October 26, 2021 as required by Order No. 2, the Maxies have been in contact with Commission Staff regarding supplementing their appeal to do so. Accordingly, the ALJ finds good cause to extend the deadline for the Maxies to cure the deficiencies previously identified by Commission Staff.

The administrative law judge (ALJ) grants the extension and amends the procedural schedule as follows:

Deadline for the Maxies:	December 6, 2021
1. to cure the deficiencies identified in Mr. Pokharel's memorandum;	
 to file with the Commission proof of notice a copy of the appeal was mailed to Consolidated WSC; and 	
3. to file an amended appeal form with all the required enclosures listed in the instructions, including an updated written estimate from Consolidated WSC, if one was provided in response to the most recent application for service	
Deadline for Commission Staff to file a supplemental recommendation on the administrative completeness of the petition	December 20, 2021

A failure by the Maxies to timely comply with the schedule adopted in this Order could result in dismissal of their appeal.
