**ORDER NO. 3**  
**FINDING APPLICATION AND NOTICE SUFFICIENT AND**  
**ENTERING PROCEDURAL SCHEDULE**

This Order addresses the administrative completeness of the application of Triton Texas Holdings LLC filed on September 22, 2021 for a change in ownership under Texas Water Code § 13.302 and 16 Texas Administrative Code § 24.243. Triton Texas Holdings filed an amended application on October 20, 2021 and supplemented its application on November 3, 2021. Commission Staff filed a supplemental recommendation on administrative completeness on November 10, 2021. Commission Staff recommended that the application and notice be found administratively complete.

Commission Staff further requested that the docket be restyled because the interest holders will no longer be parties to the proposed application. The docket is restyled as reflected in this Order.

The administrative law judge finds the application administratively complete and notice sufficient. The following procedural schedule applies:
