**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On September 22, 2021, Triton Texas Holdings LLC (TTH) filed an application for changes in ownership of Horseshoe Bend Water Company LLC (Horseshoe Bend) and Lone Star Water Company (Lone Star) under Texas Water Code (TWC) § 13.302 and 16 Texas Administrative Code (TAC) § 24.243. TTH seeks approval to acquire 100% of the issued and outstanding limited liability company interests of Horseshoe Bend and 100% of the issued and outstanding shares of Lone Star stock following a temporary transfer from Triton Utilities, Inc. (TUI) to Horseshoe Bend and Lone Star.

The administrative law judge (ALJ) filed Order No. 3 on November 16, 2021, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a final recommendation on the application or request a hearing by November 30, 2021. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff has been working with TTH in good faith to resolve all outstanding issues with the application. Staff anticipates that TTH will make a filing this week providing Staff the documents required to complete its review. Therefore, Staff respectfully requests that its deadline to file a final recommendation on the application be extended one week until December 6, 2021.

## **II. CONCLUSION**

Staff respectfully requests that the deadline to file its final recommendation be extended until December 6, 2021.
