TRITON TEXAS HOLDINGS LLC'S REQUEST FOR ACTION

Triton Texas Holdings LLC (TTH or Applicant), a Texas limited liability company, respectfully files this request for action in this matter. In support, TTH shows as follows.

On December 10, 2021, the Honorable presiding Public Utility Commission of Texas (Commission) Administrative Law Judge (ALJ) issued Order No. 6 admitting evidence in this docket, but the ALJ did not issue an order authorizing TTH's proposed transaction to proceed. While Corrected Order No. 5 does not establish a specific deadline for the ALJ's order, a previous schedule established for this matter contemplated an order issuing within one week following the parties' submission of a proposed order. TTH worked with Commission Staff to submit a proposed order on December 9, 2021, well in advance of the established December 30, 2021 deadline.

It is extremely important to TTH that it closes its proposed application transaction as soon as possible within the calendar year 2021. For that to occur, TTH believes the order needs to be issued by Wednesday or Thursday this week. TTH was hoping that by working with Staff to submit a proposed order on December 9 TTH could ensure a closing before December 31, 2021. With the passage of time, TTH has become concerned because it understands that the Commission is not open this Friday or most of next week.

TTH believes the parties' proposed order is sound and ready for issuance. If the ALJ concurs, TTH respectfully requests the ALJ promptly issue an order allowing TTH's transaction to proceed in time for TTH to close the transaction before the fast-approaching end of 2021 next week.
