TRITON TEXAS HOLDINGS LLC'S PROOF OF CLOSING

Triton Texas Holdings LLC (TTH or Applicant), a Texas limited liability company, respectfully files its proof of closing in this matter. In support, TTH shows as follows.

On December 23, 2021, the Honorable presiding Public Utility Commission of Texas (Commission) Administrative Law Judge (ALJ) issued Order No. 7 authorizing TTH's proposed transaction to proceed.¹ TTH is pleased to report that the transaction closed on December 27, 2021, and a copy of the executed transaction agreement is attached hereto as **Exhibit A**.

TTH notes one change from the proposed transaction document. TTH and Triton Utilities, Inc.'s lender, CoBank ACB (CoBank), requested TTH include language in the agreement clarifying that TTH's acquired interests will remain subject to a Pledge Agreement, dated October 20, 2020, between Triton Utilities, Inc. and CoBank. This addition does not substantively change the proposed transaction in any respect given that the acquired interests would remain subject to the Pledge Agreement regardless of whether the clarifying statement was included in the document.

TTH stands ready to work with the Commission and Staff to implement any additional steps needed to finalize and close this docket. TTH appreciates the Commission's attention to this matter.
