TRITON TEXAS HOLDINGS LLC'S REQUEST FOR EXTENSION

Triton Texas Holdings LLC (TTH or Applicant), a Texas limited liability company, respectfully files this request for extension in this matter. In support, TTH shows as follows.

On January 25, 2022, the Honorable presiding Public Utility Commission of Texas (Commission) Administrative Law Judge (ALJ) issued Order No. 8 finding closing documentation sufficient and establishing a procedural schedule.¹ The current procedural schedule is set forth below.

Deadline for applicants to file signed consent forms with the Commission	February 11, 2022
Deadline for parties to jointly file Proposed Notice of Approval, including findings of fact, conclusions of law, and ordering paragraphs	February 18, 2022

TTH and Commission Staff have conferred and determined that no change to certificates, maps, or tariffs are needed in this docket and would like those deadlines removed from the procedural schedule for this docket. Those items will be handled for Horseshoe Bend Water Company, LLC in PUC Docket No. 50085. Nevertheless, TTH respectfully requests a one-week extension of the current deadline for parties to jointly file a Proposed Notice of Approval to February 25, 2022. TTH respectfully requests that the procedural schedule for the present docket
