COMMISSION STAFF’S UNOPPOSED REQUEST FOR EXTENSION

On September 23, 2021, the Town of Lakeside (Lakeside) and the City of Fort Worth (Fort Worth) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Tarrant County. Specifically, Lakeside seeks approval to acquire facilities and to transfer water service area held under Fort Worth’s certificate of convenience and necessity (CCN) No. 12311.

On May 25, 2022, the administrative law judge (ALJ) filed Order No. 7, establishing a deadline of June 10, 2022, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to identify the evidence in the record that provides the basis of Ms. Mathis' s statements or file additional evidence and seek its admission. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requests that the deadline to identify the evidence in the record that provides the basis of Ms. Mathis' s statements or file additional evidence and seek its admission be extended to June 24, 2022. Applicants are unopposed to Staff’s request for extension.

II. CONCLUSION

Staff respectfully requests an order consistent with the foregoing request.
