## TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Tarkington Special Utility District's ("Tarkington"), and pursuant to Order No. 3, files this Response to the Administratively Complete Petition for Expedited Release by CR Farms, LLC ("CR Farms") in the above-styled proceeding under Texas Water Code § 13.2541 and 16 Texas Administrative Code § 24.245.

Pursuant to the June 15, 2021 "Agreement Concerning Certificate of Convenience and Necessity" (the "Agreement") between Tarkington and CR Farms, attached as **Exhibit D** to CR Farm's Petition for Expedited Release (the "Petition"), Tarkington does not oppose CR Farms' Petition and consents to the release of the approximately 5,482.61 acres (the "Property") from Tarkington's water certificate of convenience and necessity No. 11448, as further described in the Petition, and consistent with the terms of the Agreement. Tarkington does not object to the procedural schedule adopted in Order No. 3 and does not object to the administrative approval of the expedited release of the Property.

Tarkington will supplement this Response with a supporting affidavit from its General Manager.
