**ORDER NO. 5**  
**FINDING PETITION DEFICIENT AND NOTICE SUFFICIENT, ESTABLISHING**  
**DEADLINES FOR OPPORTUNITY TO CURE, AND RESTYLING DOCKET**

This Order addresses the sufficiency of the September 27, 2021 petition of the City of New Boston and Central Bowie County Water Supply Corporation for approval of a service-area contract and to amend certificates of convenience and necessity in Bowie County. On December 3, and 17, 2021, the petitioners filed supplemental information. On January 25, 2022, Commission Staff filed a recommendation on administrative completeness and notice.


The administrative law judge (AJ) finds the petition administratively incomplete under Texas Water Code §§ 13.248 and 13.255. 16 Texas Administrative Code (TAC) § 24.8(d), the Commission does not consider an application filed until it makes a determination that the petition administratively complete. Thus, at this time the petition is not considered filed with the Commission. The ALJ finds the notice sufficient as allowed by 16 TAC § 24.259(d).

By February 17, 2022, petitioners must supplement the petition to cure the deficiencies as described in the January 25, 2022 memorandum of Jolie Mathis. Until the Commission receives and reviews the supplemental information, the application cannot proceed.

By March 22, 2022, Commission Staff must file a supplemental recommendation regarding the administrative completeness of the petition, along with a proposed procedural schedule.
