COMMISSION STAFF'S REQUEST FOR EXTENSION

On September 27, 2021, the City of New Boston and Central Bowie County Water Supply Corporation (collectively, Petitioners) filed a petition for approval of a service-area contract under Texas Water Code (TWC) § 13.248 and to amend certificates of convenience and necessity in Bowie County.

On April 8, 2022, the administrative law judge (ALJ) filed Order No. 7, establishing a deadline of June 14, 2022, for Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the administrative completeness of the application and sufficiency of notice, along with a proposed procedural schedule. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requests this extension so that it may complete its review of the supplemental documents filed by Applicants on May 6, 2022. Accordingly, Staff requests that its deadline to file a supplemental recommendation regarding the administrative completeness of the application and sufficiency of notice, along with a proposed procedural schedule be extended to June 28, 2022.

II. CONCLUSION

For the reasons discussed above, Staff respectfully requests that its deadline to file its supplemental recommendations regarding the administrative completeness of the application and sufficiency of notice be extended to June 28, 2022.
